The space may be allotted to the participants on fulfilling Terms & Conditions and the application must be reached before 15 days from the start of the Exhibition at NHDC Ltd. Wegman Business Park, 4th Floor, Tower-1, Sector Knowledge Park III, Surajpur Kasna Main Road, Greater Noida-201306 (Uttar Pradesh)

- 1. It is essential for Participating agency to provide recommendation of every exhibition separately from their concerned WSC.
- 2. Agency must have Handloom Mark, Silk Mark & IHB Registration, Empanelled with NHDC Ltd., each and every item should be price tagged.
- 3. During the exhibition each & every Stall members shall have to follow the discipline.
- 4. Proper bill book with GST number. should be used for sales. If any agency is found using improper bill book without GST number, the agency should be debarred / black listed for participation; in future exhibitions and the matter may also be brought to the notice of WSC/DHT/DCH.
- 5. It will be responsibility of participants to collect / deposit the **GST** and other taxes if any, wherever applicable.
- 6. The participating agencies should make their own arrangements for insurance of the goods as NHDC will not be responsible for any type of damages due to any reason including Fire, Theft, Burglary, Riots, Flood, Rains etc. during the transit and in Exhibition period i.e. inside the Exhibition hall also.
- 7. NHDC is committed to make this exhibition ECO-FRIENDLY so use of Polythene bags / Plastic Bags shall not be allowed in exhibition. Alternate arrangements may have to be made by the participating agency. Apart from this chewing any kind of Pan Masala, Gutka, Tobacco and Smoking is prohibited in premises of exhibition venue. If someone found doing any kind of above said activity it will be punishable offence.
- 8. Actually the Timing of Exhibition will be from 11:00 AM to 08:00 PM, for cleaning of Hall, gate will be opened at 10:30 AM. All participating agencies must reach at the time of opening of Hall and also signature will be compulsory on the register, which will be available with Security Guards.
